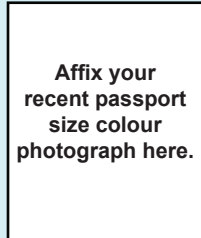

Terms & Conditions

PLEASE READ THE FOLLOWING TERMS AND CONDITIONS CAREFULLY BEFORE ENTERING THIS CONTRACT FOR ADMISSION OF YOUR CHILD

A. GENERAL:

- Rydberg Learning is a private institution and not part of any institution, and all services provided are for the extra knowledge and benefit to increase exam success and advantage for exam and competitive exam preparations.
- Although we work within the school curriculum, we do not do homework or assignment or questions that are meant to be the student's own work.
- A student agrees on submitting the enrolment form that Rydberg Learning keeps their personal records on its computerized systems. Should any circumstances change it is the student's responsibility to tell Rydberg Learning about all changes, in particular, of any changes of home address, changes to emergency telephone numbers, contact names, change of email address
- Students are expected to attend 100% of their classes students & parents.
- If any student is taking leave without prior information for 10 classes they, will not be allowed to attend further lectures or given test papers. No separate intimation will be sent to the parents or fees will be refunded.
- The application form must be signed to show acceptance of Rydberg Learning. "Terms and Conditions for Tuition".
- A student's registration, admission and enrolment for tuition classes are an agreement to pay the full fees and finish the course.
- 10% discount will be given on the admission fees for each of the siblings enrolled in our classes.
- Use of mobile phone or any cellular devices is/are strictly prohibited inside the classroom. In the event of use of such device Rydberg Learning will confiscate the same and a penal charge of ₹ 500/- (Rupees Five hundred) only will be imposed automatically.
- Rydberg Learning reserves the right to refuse to enroll any student.
- In all cases the decision of the Managing Person of Rydberg Learning will be final and binding.

B. LIABILITY:

- Rydberg Learning strives to provide the best possible service. However, we will not be held accountable or responsible for the academic success or lack thereof demonstrated by the student. Although we will do everything in our power to help grades and skill sets improve, we can offer no guarantee thereto.
- All items of personal property are brought onto Rydberg Learning premises entirely at the owner's risk. Rydberg Learning will not be held responsible nor accept any liability for any loss or damage to any such items, howsoever caused.
- Rydberg Learning, its members, management and /or employees will not be held responsible for any loss of property, damage to any life, etc. of any person enrolled in and/or attending the classes or while studying or while attending any meeting or events at the premises.
- Students and those responsible for paying their fees are liable for any damage they cause to Rydberg Learning equipment, devices, books and the premises.

C. PAYMENT OF FEES:

- Payment of all Tuition fees or non-refundable admission fees of Rs 2500.00 only must be received before the commencement of classes. All fees due to the Rydberg Learning must be paid in full, before the course can start.
- Students will be required to pay for examination fees in addition to course fees. A list of examination fees is available from reception. Examination fees depend on the type of course. It is the student's responsibility to ensure that examination fees are paid on time.
- If any payment is not made by the due date, a charge of 2% will be levied automatically as late fee.
- Rydberg Learning will impose a ₹300/- administration charge in all cases of dishonoured cheques
- Non-payment of any month's fees may result in the pupil being excluded from further classes.

D. MODE OF PAYMENT:

E. COMMENCEMENT OF TUITION:

A child may only attend classes once Rydberg Learning has received a non-refundable/non-transferable deposit together with one month's course fees in advance. Class timetable(s) will be available from the reception desk.

F. GROUP SIZE:

Groups are usually between 10-20 students.

G. MISSED LESSONS:

If a lesson is cancelled by Rydberg Learning, an extra-help class(es) will be arranged to replace it. If a student misses a class due to family commitments or illness and cannot be booked into another class, the student may be booked into an individual extra-help session at the sole discretion of the concerned teacher.

H. APPLICATIONS TO SCHOOLS / COLLEGES:

It is the sole responsibility of the parents to make applications to various schools / colleges (the teacher can only advise).

I. COURSES:

Rydberg Learning reserves the right to move or merge any class where there is insufficient demand or any other justifiable reason to do so. Hence, change of tutors may also be possible. For cancelled classes Rydberg Learning will offer an alternative class.

J. FORCE MAJEURE:

In the event of 'force majeure' such as fire, flooding, infectious diseases, war and other events, outside the Rydberg Learning reasonable control which may cause the closure of the Rydberg Learning Centre, no refund of fees will be made to students

K. REFUND POLICY:

- Refunds will only be given after the course start date in exceptional circumstances and such refunds may take up to 120 days to process.
- Rydberg Learning does not permit transfer of course fees from one student to another.
- If the student changes his/her mind and cancel his/her tuition classes prior to his/her first class, he/she will be refunded the advance monthly tuition fees for the said month. However, admission fees / charges will be forfeited.
- In cases of inappropriate or offensive behavior, Rydberg Learning reserves the right to terminate the said student without refund with immediate effect.
- In the event of a child withdrawing from the course part way through the month, the course fee deposit for that month will be retained and is not transferable.
- If a student is dismissed for misconduct, no refund will be given.
- No refund will be made if a student is late or leaves early we will charge the full price for the tutorial.
- No tuition refunds are given for any missed classes.
- No refunds will be given in case of cancellation of registration / admission.
